

## WEST VIRGINIA STATE ATHLETIC COMMISSION PROMOTER'S LICENSE BOND

## KNOW ALL MEN BY THESE PRESENTS:

That we \_\_\_\_\_\_\_, as Principal, and \_\_\_\_\_\_\_, a firm and/or a corporation authorized to do business in the State of West Virginia, as Surety, are held and firmly bound to pay unto the boxing, sparring or exhibition contestants and event staff for all purses, awards and payments to be paid by the promoter, in the just and full sum of Twenty Thousand Dollars (\$20,000.00) to the payment whereof well and truly to make, we bind ourselves, our heirs, executors, administrators, successors, and assigns, jointly and severally, firmly by these presents.

WHEREAS, the above-bound Principal, has made application to be licensed as a boxing promoter in the State of West Virginia, and is required to post a surety bond under the provisions of West Virginia Code §29-5A-15 prior to the issuance of such license;

**NOW THEREFORE,** the condition of this obligation is such that, if the above-bound Principal shall, for the period for which the license is granted, make timely and full payment of all purses, awards and other payments legally due to all contestants and event staff participating in the professional or semiprofessional boxing matches, competitions or exhibitions organized by the Principal as a licensed promoter, then this obligation shall be void; otherwise to remain in full force and effect; and

**THIS BOND** shall be effective from the date of execution shown below, until the license granted to the Principal expires on the 30th day of June, \_\_\_\_\_\_. This obligation may be continued from year to year by the Surety issuing a continuation certificate and any continuation shall establish a new bonding period.
