## WEST VIRGINIA ATHLETIC COMMISSION

January 25, 2018

### **Call to Order – Approval of Minutes**

A meeting of the West Virginia Athletic Commission was called to order January 25, 2018 at approximately 11:00 AM.

Peasak. Secretary Thornton also moved to approve V. Abreu as a replacement for J. Lester against Matt Conway. Motion was seconded by Commissioner Dr. Peasak and passed by unanimous voice vote.
